- ▶ **Undergraduate (UG):** Minimum 60% in 12th | IELTS 6.0 (no band < 5.5)
- ▶ **Postgraduate (PG):** 60%+ in Bachelor | IELTS 6.5 (no band < 6.0)
- ▶ **Accepted Alternatives:** PTE, TOEFL

- 1 Year Tuition Fees – As per university offer
- OSHC – Overseas Student Health Cover
- Travel Expenses – Approx. AUD 2,000

- Per Child: AUD 4,449

▶ Accepted Financial Documents:

- Education loan sanction letter (RBI-approved bank)
- Personal/parent's bank savings

▶ Not Accepted as Financial Evidence:

- Kisan Vikas Patra (KVP)
- Life insurance policies
- Loan against Fixed Deposits (FDs)
